I fully understand, agree, and will therefore abide by the following SCHOOL BUS RULES AND REGULATIONS.

- 1. The bus service is on an annual basis. Bus fees must be paid in advance either on a yearly or quarterly basis. In case of cancellation of service for any reason, fees must be paid in full. In case of transfer to a residential location, the school must be informed at least two weeks before the intended date of transfer. Slot/service is subject to the availability.
- 2. Riders must be in the designated area 5 minutes before the given pick-up time. Likewise, they must proceed immediately to the bus after the dismissal to avoid delays.

3. Parents/Guardians of preschoolers must be at the designated area 5 minutes before the arrival of the bus. If the parent/guardian is not in the area, the child will be brought back to the school and the child must be fetched there.

- 4. Bus Supervisors will not call up the parent/student or send information in the morning unless during an emergency. Any concern must be addressed directly to the bus supervisor for prompt action and solution. For safety reasons, parents must avoid calling the driver while driving.
- 5. There are designated bus drivers according to the location of each student/rider. Transferring to another bus is subject to the availability of the seat.
- 6. Proper behavior must be observed on the bus at all times. Vandalism, littering, or other misconduct that may cause damage to the bus or inconvenience to the other riders, drivers, and Bus Supervisors, will be dealt with according to the school's discipline policies. Damage to school property will be paid/replaced accordingly.
- 7. Parents/Guardians are not allowed to ride in the bus. The school deserves the right to cancel the bus service as the penalty for misconduct and unacceptable behavior either of the student or the parent toward the school management. Rule #1 will be applied.
